# AGENDA ITEM #2 APPROVE THE MINUTES OF THE REGULAR MONTHLY MEETING OF JUNE 12, 2024.

Director Sullivan attended a GWPCA meeting and reported that the flows for the Heritage River Development project have been adjusted down to 105000 gallons per day. Phase 1 for the project is scheduled to begin this fall.

Chairman Demicco inquired about the Wastewater Plant's flood wall. It was reported that construction will begin in September and will take approximately six months to complete.

Director Sullivan advised the Board that an electric cross arm needs replacement, and it will be done in at least two phases. Due to the extreme heat, the linemen will begin in the early hours of the day when it should be cooler.
